GENERAL EVENT REGULATIONS

SNIM - SALONE NAUTICO di PUGLIA 2026

Art. 1 ORGANIZERS - LOCATION AND DATES

SNIM is organized at the Marina di Brindisi Tourist Port by Sea Event Agency Srl, with registered office in Brindisi, Via Giuseppe Doldo 29, 72100 Brindisi, Tax Code/VAT number: 02578490746, hereinafter referred to as the Organizer, the trade fair event called: "SNIM - Salone Nautico di Puglia hereinafter referred to as the Event. The Event will take place from October 22th to 26th, 2026.

Art. 2 ALLOWED EXHIBITION PROFILES FOR PARTICIPATION

The companies that are allowed to participate exhibit products and services of their own production or their dealers, agents, retailers, exclusive representatives for Italy of foreign companies. The trade associations, economic organizations, and institutions that institutionally carry out promotion actions for the sector, study activities, information, and dissemination in the specific field.

The products, machinery, and services presented during the event, whether owned by participating companies, the companies they represent or host, must still adhere to the product range of the event:

- Nautical clothing
- Accessories for boating and fishing
- Equipment for boating and fishing
- Boats
- Nautical tourism
- Trade associations
- Publishing
- Food and beverage

Art. 3 PARTICIPATION PROCEDURE

Companies wishing to participate in the event can apply by sending the duly completed application form in pdf format to the email snim@snimpuglia.it, duly signed in all its parts with the company's stamp and the signature of the Legal Representative, in addition to this General Event Regulation. It is specified that with the submission of the Participation Proposal, which constitutes the official participation contract, it is mandatory to make the simultaneous payment of the 30% deposit + VAT. The balance must be made within the timeframes specified in the application form.

Art. 4 EXCLUSION FROM THE EVENT OR FAILURE TO PROVIDE SERVICES

The Organizer reserves the right to not accept the application for participation. In this case, any advance payment made by the company will be refunded. No further compensation will be due as a result of the withdrawal, and the Organizer will have the right to allocate the area to other interested parties. If the balance payment is not made within the specified terms in the application, the Organizer reserves the right to not allow the company or any appointed exhibitors to set up the booth. If a pre-arranged area is provided by the Organizer, do not personalize the booth with the participant's distinctive signs.

Art. 5 EXHIBITION SPACE

The assignment of exhibition spaces is decided by the Organizer, taking into account the general interest of the exhibition, the priority of the date of receipt of the "application for participation", the requested surface area, and, as far as possible, the preferences expressed by the Contractor. The exhibitor may only set up their exhibition area within the granted surface area and, in any case, in full

compliance with the specified terms. The exhibitor who wishes to set up their exhibition area outside of what was agreed upon is required to give prior notice. The organizer may accept or reject the setup project, applying a surcharge to the agreed rent, based on the rates specified in the application for participation. It is strictly forbidden to sublet or transfer, even for free, the booth or part of it without the prior authorization of the Organizer. In such cases, participants who host other companies within their booth must pay a sum of €500.00, including the registration fee (€200.00), for each of the hosted companies. The hospitality fee and the registration fee will also be invoiced to the Participant who, without prior authorization from the Organizer, hosts companies at their booth that were not declared through written communication.

Art. 6 SET UP

The set-up activities, including the arrival of the boats, must take place from 8:00 am to 4:00 pm, starting from 3 (three) days before the opening of the event. All advertising materials (banners, flags, stickers, etc.) must be applied without damaging the existing structures. The exhibition areas can only be dismantled at the end of the event, and under no circumstances is it allowed to pack up the displayed materials before that deadline. The clearance must be completed by the evening following the closure of the event. The boats can leave the event venue starting from the day after the end of the event and no later than 1:00 pm on the second day after the end of the event.

Art. 7 CANCELLATION

The Participant who, after countersigning the participation proposal, does not intend to attend the Event, must communicate their withdrawal to the Organizer, always in written form and stating the reasons. If the withdrawal is received by the Organizer by September 15, 2026, nothing will be owed by the participant. If the withdrawal is received by the Organization after September 15, 2026, the penalty will be equal to the deposit (30% + VAT).

Art. 8 NON-PARTICIPATION

Participants who have not occupied their area or started their setup by 12:00 PM the day before the inauguration will be considered in default for all purposes and, without prejudice to any further damages, will be required to pay a penalty equal to the entire participation fee; in this case, the Organizer will also have the right to use the aforementioned area by assigning it to other interested parties.

Art. 9 CANCELLATION - SUSPENSION OF EVENT

If, for any reason, including force majeure, the Event cannot take place, the signed participation proposal will be automatically resolved and the Organizer will refund the participant any amounts already paid. However, if the Event is suspended due to force majeure after the opening date, no refund is due to the participant. In none of the above scenarios is Sea Event Agency Srl obliged to provide any form of compensation or indemnity to the participant.

Art. 10 RETAIL SALE

The sale of products is allowed in compliance with all regulations governing their marketing, including the possession of a valid license, which the operator must comply with, with Sea Event Agency Srl being exempt from any responsibility in this regard. Any administrative and tax burdens for the proper execution of the sale are also entirely the responsibility of the operator, without Sea Event Agency Srl assuming any liability in case of non-compliance by the operator. Sea Event Agency Srl also declines any responsibility in case of malfunctioning of the operator's POS, even if the malfunction is due to technical issues related to Wi-Fi.

It is also clarified that any disputes between operators (unfair competition, sale of similar products, etc.) must be resolved directly between the operators themselves, with Sea Event Agency Srl being completely exempted.

Art. 11 DAMAGES - INSURANCE

Sea Event Agency Srl assumes no responsibility for damages to persons and property, caused by anyone and in any way. The organization only provides the "THIRD PARTY LIABILITY" guarantee to the Participant and its employees during the trade fair period, including setup operations (excluding loading and unloading of goods/materials) and dismantling of stands, as well as any demonstrations and practical tests, excluding liability of the insured as a producer. Other participants are considered third parties. The guarantee does not cover damages to one's own property and property held for any reason. The insurance amount is included in the Registration Fee. However, the Participant may directly arrange for additional coverage they deem appropriate and convenient, regardless of what is previously provided. The participant releases Sea Event Agency Srl from any liability arising from the presence of goods, equipment, furnishings, stands, etc. at the event areas.

Art. 12 SAFETY REGULATIONS

Exhibitors are required to comply with the provisions of the Public Security Authorities and those responsible for fire prevention, accident prevention, and surveillance of premises open to the public. The exhibitor must be present at their exhibition area when the Safety Commission passes by and must have all the technical documentation certifying the materials used.

Art. 13 REGULATIONS AND SUBSEQUENT AMENDMENTS AND INTEGRATIONS

The Organizer reserves the right to modify and/or supplement at any time the General Regulations of the Event with provisions aimed at regulating the trade fair activity. The amendments will be promptly communicated in writing to the exhibitor. In the event of non-compliance with the provisions of the General Event Regulations by the Participants and/or their collaborators, the Organizer reserves the right to take appropriate legal action in order to claim compensation for damages suffered.

Art. 14 COMPLAINTS - JURISDICTION

For any complaint and/or dispute arising from the interpretation, execution, and validity of this regulation, the competent jurisdiction is exclusively the Court of Brindisi. The relationship is governed solely by Italian laws.

EXHIBITOR PROMOTION ON THE EVENT'S MEDIA

Art. 15 PROMOTIONAL CHANNELS AND PURPOSE

The Organizer promotes Exhibitors' presence through SNIM's official social media channels (website, Facebook, and Instagram).

This activity aims to enhance the Exhibitor's brand and create engagement with the Show's audience. The Exhibitor acknowledges the Organizer's right to use logos, trademarks, and corporate images for these promotional purposes, releasing the Organizer from any copyright liability for the materials provided.

Art. 16 MATERIAL REQUIREMENTS AND VISUAL QUALITY

To ensure a consistent and prestigious image of the event, multimedia materials (logos, photos, and

videos) submitted by Exhibitors must meet minimum quality standards (high resolution). Materials that are grainy, poorly lit, or do not conform to the event's decorum will not be considered. The Organizer reserves the right not to publish content that could damage the image of the Show or other participants.

Likewise, if the Exhibitor (or interested party) discovers errors, misleading, or harmful information, they are asked to promptly notify the SNIM organization to ensure the highest quality of communication activities.

Art. 17 EDITORIAL SCHEDULE AND PRIORITY CRITERIA

The order and date of publication of posts on social media channels are determined by the SNIM Communications Office, based on an integrated communication strategy. Priority in the editorial calendar will follow the chronological order of administrative completion (subject to payment of the registration fee).

Each exhibitor will be contacted via email at the address provided upon registration. If, following a request, the Exhibitor fails to provide the necessary materials in a timely manner to coordinate communication activities, the Organization will proceed with the planned editorial plan so as not to slow down the overall promotion of the fair, thus not guaranteeing individual exhibitors' social media coverage.

Art. 18 OFFICIAL WEBSITE

The Organizer has reserved a dedicated area on the official website www.snimpuglia.it where participants in the 2026 edition will be listed. Exhibitors will be included in this list (including their logo and company name) only after administrative processing and payment of the participation fee. Listings in the public database will follow chronological priority criteria based on the fee payment date.
